Most of the work is divided evenly, but there are some operations in the fourth stage you couldn't split into pieces so the fourth stage needs 1300 picoseconds to run while the other five stages only need 1000 picoseconds each. Assume that those times include the pipeline register delays.

Question 8 [2 pt]: (see above) What is the difference between the clock cycle duration needed for this pipeline and the clock cycle duration that would have been needed if stages could have been split evenly? Answer in picoseconds.
